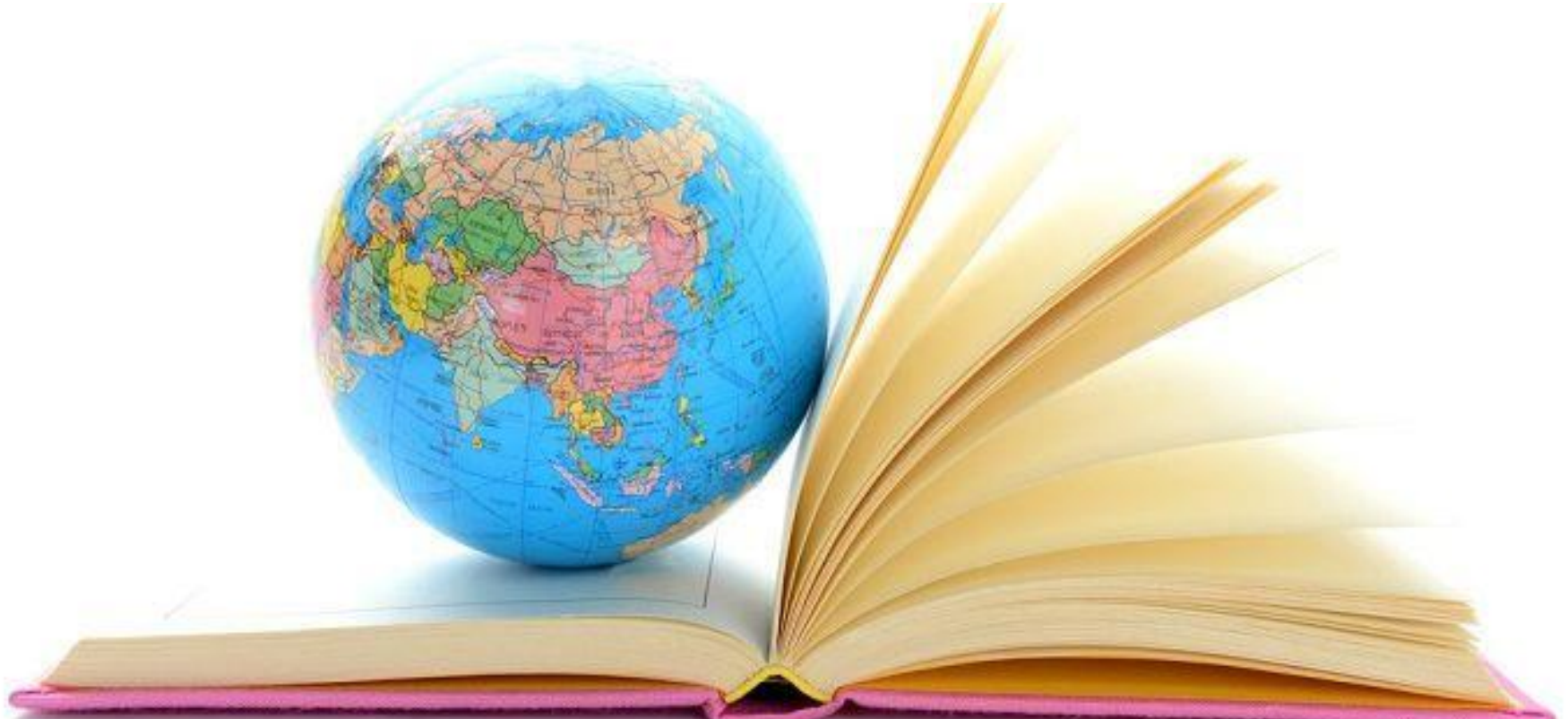

Partner university overseas ([Outside of Europe](#))

- Remain enrolled at UZH
- No semester fees at host university
- Application via [Mobility-Online](#)
- Deadline 15 January

Other accredited university ([Self-Organization](#))

- University needs to be accredited
- Pay extra attention to course offering
- Remain enrolled at UZH (important for credit recognition)
- In case of fees at host university, reimbursement of UZH semester fees

Switzerland ([CH - Unimobil](#))

- Remain enrolled at UZH
- No semester fees at host university
- Application via Student Administration Office ([application form](#))
- Deadline 31 March (fall)/ 15 Oct. (spring)

Application Mobility- Online (student)

- Max. 3 priorities (4th in motivation letter)
- Motivation letter (1 page, max. 2) in German or English
- No further documents are needed from IKMZ side
- No language certificate required (but credibly demonstrate that the necessary diploma can be submitted by registration deadline)

Allocation criteria (UZH/IKMZ)

- Timely submission of complete application
- Grades
- Motivation letter (academic added value desired partner university)
- Sufficient knowledge of the language of instruction
- Study plan (does not need to be final course selection)

Nomination (UZH/IKMZ)

- March - May (fall) & Sept. - Oct. (spring)

Registration (student)

- Partner university informs directly on next steps
- Decision about the final admission lies with the partner university



Course selection & credit recognition

- Check course offering at host university
- Suitable modules for credit recognition are level & subject appropriate elective lectures & elective seminars (module groups “Weitere Themenfelder ...”/ “Anwendung ...”/ “Forschungsbereiche ...”/ ”Qualifizierung ...”/ ”Further topics in the field...”)
- Courses + descriptions to IKMZ for credit recognition agreement (AV)
- European partner university: upload Learning Agreement (LA) (template in Mobility-Online) before exchange semester starts
- After semester abroad send Transcript of Records (ToR) to IKMZ

Learning Agreement

The purpose of the Learning Agreement is to provide a transparent and efficient preparation of the study period abroad and to ensure that the student will receive recognition in his/her degree for the courses successfully completed abroad. By signing this document, the student, the Sending Institution and the Receiving Institution confirm that they approve the Learning Agreement and that they will comply with all the arrangements agreed by all parties. Sending and Receiving Institutions undertake to apply all the principles of the Erasmus Charter for Higher Education relating to mobility for studies or the principles agreed in the Inter-Institutional Agreement. The Receiving Institution confirms that the courses listed in the table below are in line with its course catalogue and should be available to the student. The Sending Institution commits to recognise all the credits or equivalent units gained at the Receiving Institution for the successfully completed courses and to count them towards the student's degree. Any exceptions to this rule are documented in an annex of this Learning Agreement and agreed by all parties. The student and the Receiving Institution will communicate to the Sending Institution any problems or changes regarding the study programme, responsible persons and/or study period.
